### **OCME OVERVIEW**

#### OFFICE OF THE CHIEF MEDICAL EXAMINER:

The Virginia Office of the Chief Medical Examiner (OCME) is a statewide medical examiner system with four regional district offices encompassing 17 forensic pathologists and a Chief Medical Examiner. The Office of the Chief Medical Examiner is responsible for determining the cause and manner of deaths that occur under certain circumstances in Virginia. Every case we undertake has two equally important components: the emotional and practical issues of family members and the scientific aspects of the investigations we conduct.

By the nature of the work we do here, we have become especially sensitive to the needs of families. And we are acutely aware of the precise scientific analysis that law enforcement agencies require. Each member of the medical examiner's staff is committed to providing the respect families deserve and the detailed information demanded by the legal community.

Our website provides helpful, easy-to-understand information about our processes, the medical and legal requirements of our job, and medical and statistical reports.



#### **ABOUT THE MEDICAL EXAMINER:**

Virginia became one of the first states to institute a statewide medical examiner system in 1946. In that year, the General Assembly of Virginia abolished the office of Coroner's Physician and appointed a Chief Medical Examiner. Four years later, in 1950, the Office of the Chief Medical Examiner (OCME) became a division within the Virginia Department of Health.

In Virginia, medicolegal death investigators conduct a medicolegal death investigation, serving as the principal case investigator for deaths falling within the OCME statutory authority. The OCME currently supports more than 160 local medical examiners, who may conduct scene investigations in their locality. The OCME receives the initial notification of death and determines if the death should come under the jurisdiction of the medical examiner. Local medical examiners may examine and sign the certificate of death on medical examiner cases, or using professionally established guidelines, refer certain classes of cases for more intensive death investigation and medicolegal autopsy.

When an autopsy is required, it is conducted in one of four district offices: Manassas, Norfolk, Richmond or Roanoke. Each district is staffed by board certified forensic pathologists, death investigators, administrative, and morgue personnel. The Chief Medical Examiner, Dr. William T. Gormley, is responsible for the overall operation of the state's medical examiner system.

Virginia's medical examiners and forensic pathologists are committed to public safety and to public health. To promote public safety, they testify to their findings in civil and criminal courts throughout the Commonwealth. They advance public health through their investigations of deaths that present a hazard to Virginia's citizens, such as emerging infections and bioterrorism. Public health is also supported through a well-established surveillance and fatality review program, one of a few forensic epidemiology units in the nation. The State Child Fatality Review Team, as well as maternal mortality review and intimate partner homicide surveillance projects are all located within the OCME. In 2002, Virginia became a demonstration site for the National Violent Death Reporting System.

#### PURSUANT TO SECTION 32.1-283 OF THE CODE OF VA THE FOLLOWING DEATHS ARE **INVESTIGATED BY THE OCME:**

- > Any death from trauma, injury, violence, or poisoning attributable to accident, suicide or homicide:
- > Sudden deaths to persons in apparent good health or deaths unattended by a physician;
- > Deaths of persons in jail, prison, or another correctional institution, or in police custody (this includes deaths from legal intervention)
- > Deaths of persons receiving services in a state hospital or training center operated by the Department of Behavioral Health and Developmental Services;

- > The sudden death of any infant; and
- > Any other suspicious, unusual or unnatural death.



#### OCME VISION

The overall vision of the OCME is to be the best medical examiner possible. The following missions form the core of OCME staff members' efforts in accomplishing this goal:

- Conduct medicolegal death investigations.
- > Perform autopsies to certify cause and manner of death.
- > Provide public service to citizens and professional colleagues throughout the Commonwealth.
- > Educate peers and professionals on subjects related to death investigation.
- > Reduce violent death by conducting surveillance and fatality review.
- Provide support and technical assistance to local fatality review teams.
- Administer the State Anatomical Program.





### **POSITION OVERVIEW**



#### **ABOUT THE ASSISTANT CHIEF MEDICAL EXAMINER POSITION:**

The Virginia Office of the Chief Medical Examiner is seeking an Assistant Chief Medical Examiner to join the staff of three current forensic pathologists for the OCME Western District, based out of Roanoke, that covers the western region of the state of Virginia. The successful candidate will conduct postmortem exams, approximately 250 medicolegal autopsies per year, consultations with interested parties, court testimony, supervision of staff, and other administrative oversight duties. This position advises/supervises local medical examiners as part of a fifty-five-year-old statewide medical examiner system. Educational responsibilities include the instruction of forensic pathology fellows, medical students, public safety officers, and others. The pathologist will participate in educational, training and research activities, and participate on committees. This role offers a great work-life balance with Sundays off, holiday rotation, and no on scene requirements except in emergency situations. This role requires occasional overnight travel.

### **EXPERIENCE AND MINIMUM REQUIREMENTS:**

The minimum requirements for this position are: experience performing forensic autopsies and postmortem examinations, ability to write and converse competently and clearly in the English language, ability to get along with other professionals and community officials, ability to communicate effectively as a teacher, completion of approved training program in forensic pathology (at least one year of experience), a medical licensure in Virginia (or obtain one upon employment), Board Certification or eligibility in anatomic and forensic pathology required with American Board of Pathology (or certification must be achieved within 2 years of employment), and a valid driver's license.

### **JOB CONTINGENT UPON:**

A Successful completion of a fingerprintbased background check and completion of Statement of Economic Interest required upon employment.

### **COVID POLICIES:**

In accordance with Executive Directive #18, as a condition of employment, the Commonwealth of Virginia requires all Executive Branch employees to disclose their vaccination status. Proof of vaccination will be required during new employee orientation on your first day of work. Employees that are not vaccinated must be tested weekly.

#### COMPENSATION:

The annual salary range for this position is \$180,000-\$230,000.

Medical, Dental, Vision	Wide range of State Health Benefit Plans and options that include medical, dental, vision, prescription drug coverage, behavioral health, Employee Assistance Programs, and free wellness visits.

Annual Leave	Accrued or earned after each semi-monthly pay period and is based on years of service.  - <u>0-5 Years of Service</u> : Employees accrue leave of 4 hours per pay period, up to 12 calendar days per year.  - <u>After every 5 Years of Service</u> : The accrual rate increases by 1 hour up to a maximum of 9 hours per pay period, or 27 calendar days per year.
Retirement	Membership into the Virginia Retirement System (VRS) is automatic. The VRS retirement plan is a qualified 401 (a) defined benefit plan which pays eligible members a lifetime benefit amount based on years of service, age, and compensation.
Available Voluntary Saving Plans	The Commonwealth's Deferred Compensation Plan is a voluntary tax-deferred retirement savings program that is available to individuals who are employed by the Commonwealth of Virginia in either a salaried or wage position.
Holidays	13 Paid Holidays: New Year's Day, Martin Luther King Jr. Day, Presidents Day, Memorial Day, Juneteenth, Independence Day, Labor Day, Columbus Day, Election Day, Veteran's Day, Thanksgiving (2 days), Christmas Day
Educational Leave & Assistance	Leave may be provided at the discretion of the agency for the purpose of allowing employees time to further their education. Employees may receive full or partial pay or may be placed on unpaid leave. Financial assistance may be provided for study related to an employee's work.
Compensatory Time	Non-exempt employees are eligible for paid time off for working additional hours outside of the standard workweek; having worked on an official office closing day, a holiday, a scheduled day off, or when a holiday falls on employee's scheduled day off.  - Eligible employees accrue compensatory leave on an hour-for-hour basis.  - Accrued compensatory time leave lapses within 12 months from the date it is earned, and once lapsed, compensatory leave may not be used or paid off upon an employee's change of status.

### ROANOKE'S RICH HISTORY

### **EARLY SETTLERS**

The first pioneers explored the Roanoke Valley region as early as the 17th Century. An exploration party's report in 1671 told of the "blue mountains and a snug flat valley beside the upper Roanoke River." For the next 70 years, after this initial exploration, the region remained undisturbed by settlers. As the land to the east of the mountains became developed, pioneers began moving into the western regions of Virginia. These early settlers from eastern Virginia were joined by people from Pennsylvania seeking new lands in the rich Shenandoah Valley. The newcomers began farming in the Roanoke Valley by 1740.

### **TOWNS**

Towns formed within what is now the City of Roanoke in the first decades of the 19th Century. Antwerp was subdivided in 1801 followed by Gainsborough in 1825 (the present Gainesboro neighborhood) and Old Lick in 1834. The Gainsborough settlement remained the most populous community until 1874 when the Town of Big Lick was chartered. Named for a series of salt marshes, or licks as they were called, that ran through the area and brought gatherings of buffalo, elk and deer, this tiny village of less than 500 people was to become the Town of Roanoke in 1882 and in 1884, the City of Roanoke. The new town was located along the old Atlantic, Mississippi, and Ohio Railroad later to become the Norfolk and Western.

### SHENANDOAH VALLEY RAILROAD

The completion of the Shenandoah Valley Railroad from Hagerstown, Maryland, to its junction with the newly formed Norfolk and Western Railway in 1882, marked the start of Roanoke's rapid growth. The adjacent town of Vinton was also incorporated at this time.

### **COUNTY SEAT**

The Town of Salem, established in 1806, became the county seat for Roanoke County. Salem was the largest town within the area during these formative years and was located on two stage lines. Salem remained the major center of activity in the Roanoke area until the mid 1880's and then became an independent city in 1968.


